

SECTION 10. 38

An ordinance extending the corporate limits of the Village of Mayer to include certain platted or unplatted land not exceeding 300 acres.

Section 1. A petition has been filed with the governing body of the Village of Mayer, Minnesota by the sole owner or all of the owners in number of the following described real estate to such land included within the Village of Mayer, Minnesota:

Tract 1. That part of the N.W. 1/4 of the S.W. 1/4 of Section 6, Township 116, Range 25, described as follows: Beginning at the N.E. corner of said 1/4 - 1/4 thence East along the North Line of said 1/4 - 1/4 a distance of 333.0 feet; thence South parallel with the West Line of said 1/4 - 1/4 a distance of 631.6 feet to the actual point of beginning; thence continuing South along said parallel line 175.0 feet; thence East parallel with said North line 950.0 feet; thence North parallel with said West line 175.0 feet; thence East parallel with said North line 950.0 feet to the point of beginning. (3.816 Acres)

Tract 2. That part of the N.W. 1/4 of the S.W. 1/4 of Section 6, Township 116, Range 25, described as follows: Beginning at the N.E. corner of said 1/4 - 1/4 thence East along the North Line of said 1/4 - 1/4 a distance of 333.0 feet; thence South parallel with the West Line of said 1/4 - 1/4 a distance of 631.6 feet to the actual point of beginning; thence continuing South along said parallel line 50.0 feet; thence East parallel with said North 530.0 feet more or less to the Southwesterly right of way line of State Highway No. 25; thence Northerly along said right of way line 52.0 feet more or less to the intersection with a line drawn parallel with and 606.6 feet South of said North line; thence East along said parallel line 299.45 feet more or less to the point of beginning. (0.502 A.)

Tract 3. A correction in the description of real estate in Tract 1, Ordinance No. 34, as follows: Beginning 703.0 feet South of the N.E. corner of the S.E. quarter of Section 4, Township 116, Range 25, the place of beginning; thence South 140.0 feet to a point; thence West 99.0 feet to a point; thence North 140.0 feet to a point; thence East 99.0 feet to the point of beginning. That portion of the above described real estate amounting to 0.03 acre, which is now outside the Village of Mayer limits and located in Aldrich Township. The entire above described property is now owned by A. H. Guetzlow.

Section 2. The quantity of land embraced within the foregoing descriptions and bounded as described, is 4.188 acres, exclusive of land for right of way purposes.

Section 3. The Village Council hereby determines (1) that the emasculation will be to the best interests of the Village of Mayer, Minnesota and of the territory affected; (2) that the territory described herein abuts upon the Village and is so situated as properly to be subjected to Village government.

Section 4. Therefore, the Village of Mayer, Minnesota hereby claims and declares that the property herinbefore described be and the same is hereby annexed to, and included in the Village of Mayer, Minnesota, as effectively as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the Carver County Auditor and the Secretary of State, and from and after its passage and publication.
