

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE  
VILLAGE OF ROSEMOUNT, MINNESOTA AND  
DECLARING SAID LANDS TO BE AN ADDITION TO SAID VILLAGE

The Village Council of the Village of Rosemount, Minnesota  
Ordains as follows:

Section 1. That the following described real estate,  
situated in the County of Dakota, State of Minnesota, owned by  
the Village of Rosemount, Minnesota, and abutting upon and con-  
tiguous to said Village, is hereby annexed to the Village of  
Rosemount and declared to be an addition thereto:

All that part of the Northeast Quarter  
(NE $\frac{1}{4}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ) of  
Section Twenty (20), Township One hundred  
fifteen (115), North Range Nineteen (19)  
West, described as follows:

Commencing at a point on the South line of  
said Quarter/Quarter section where it inter-  
sects the West right of way line of the  
Chicago, Milwaukee, St. Paul Railway Company,  
thence West on said South line 398 feet  
to the actual point of beginning; thence  
North at right angles 350.3 feet, thence  
West on a line parallel to the South line  
of said Quarter/Quarter section 543.26  
feet; thence South 350.3 feet to said  
South line, thence East along said South  
line 543.26 feet to the actual point of  
beginning, containing 4.37 acres, more or  
less, according to the Government Survey  
thereof.

Section 2. That this ordinance shall take effect from  
and after its passage and publication; and that upon the passage,  
approval and publication of this ordinance, the Village Clerk is  
hereby directed to cause certified copies hereof to be filed in  
the office of the County Auditor of Dakota County, Minnesota,  
in the office of the Secretary of State for the State of Minnesota,  
and in the office of the Municipal Commission of the State of  
Minnesota.
