

ORDINANCE NO. 1661

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ALBERT LEA TO INCLUDE CERTAIN PLATTED LAND

Introduced by Councilman Wallace A. Madson

WHEREAS, A petition has been filed with the governing body of the City of Albert Lea, Minnesota signed by all of the owners of the following described real estate to have such land included within the City of Albert Lea, Minnesota:

A part of Lot 1, Hewitt's Sub division Freeborn County described as follows: Commencing 33 feet West and 90 feet South of the Northeast corner of the SE 1/4 of Sec. 17, Tp. 102, R. 21 on the West line of Broadway St. extended South from the City of Albert Lea in said county of Freeborn, thence running South 110.4 feet, thence West parallel with the North line of said SE 1/4 of Sec. 17, 265 feet; thence North parallel with the first mentioned line 170.5 feet to the South line of Poplar St. in said City of Albert Lea; thence East on the South line of Poplar St. aforesaid 207.5 feet; thence Southeasterly 83.2 feet to the place of beginning, containing one acre more or less. (Poplar St. now known as West Seventh Street)

The quantity of land embraced within the foregoing description, and bounded as described, is one acre, more or less.

THE CITY OF ALBERT LEA DOES ORDAIN:

Sec. 1. That the annexation will be to the best interests of the City of Albert Lea and to the territory affected; that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

Sec. 2. That the property hereinbefore described be and the same is hereby annexed to, and included in the City of Albert Lea as effectually as if it had originally been a part thereof.

Sec. 3. That the property annexed by this ordinance is hereby zoned as R-1, one and two family district.

Sec. 4. That this ordinance shall be final and shall take effect and be in force from and after filing certified copies thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State and from and after its passage and publication.
