ORDINANCE #50  
AN ORDINANCE EXTENDING THE  
CORPORATE LIMITS OF THE VIL-  
LAGE OF YOUNG AMERICA, TO  
INCLUDE CERTAIN UNPLATTED  
LANDS NOT EXCEEDING 200 ACRES

Section 1. - Petitions having been filed with the governing body of the Village of Young America, Minnesota, by the solo owners, to-wit: Harold C. Smith and Cordelia Smith, his wife and Frieda Korschgen, of the following described real estate, to have such land included within the Village of Young America, Minnesota:

The Harold C. Smith and Cordelia Smith tracts:

Tract #1. - Commencing at a point on the center line running North and South of Section 11, Township 115 Range 26, said point being 14.80 chains North of a post which stands in the center of Section 11, Township 115 Range 26; thence running North  $89^{\circ}10'$  West, 155 feet; thence South  $0^{\circ}50'$  West, 365.3 feet to center line of Carver and Gloucee road; thence South  $55^{\circ}23'$  East, 91 feet 10 inches; thence North parallel to center line of said Section to a point 267½ feet South of the North line of the within described tract; thence East to a point on center line of said Section, 267½ feet South of the place of beginning; thence North on center line of said Section, 267½ feet to the place of beginning. Containing one and one-tenth acre, more or less.

Tract #2. - Commencing at the Northwest corner of Lot 8 of Block 3 of Smith's Addition to the Village of Young America; thence due North 186 feet; thence South  $89^{\circ}13'00''$  West, for 333 feet; thence due South for 306.00 feet; thence North  $89^{\circ}13'00''$  East for 333.00 feet; thence due North for 120 feet to the point of beginning. Containing 2.33 acres, more or less.

The Frieda Korschgen Tract:

Commencing at a point 14.00 chains North of a post which stands in center of Section 11 Township 115 Range 26; thence running North  $89^{\circ}10'$  West, 356 feet; thence South  $0^{\circ}50'$  West, 165 feet to the point of beginning of the tract to be herein described; thence East parallel to the first described line, 201 feet; thence South  $0^{\circ}50'$  West, 203.3 feet more or less, to the center of the Highway known as the Carver and Gloucee road; thence North  $55^{\circ}23'$  West along the center of said road to a point 356 feet West of the North and South center line of said Section; thence North to the place of beginning.

Containing approximately three quarters of an acre of land.

Excepting from the foregoing described tract that portion thereof taken for Trunk Highway purposes.

Section 2. = The quantity of land embraced within the foregoing descriptions, and bounded as described, is approximately 4.18 acres not excepting that portion thereof taken for Trunk Highway purposes.

Section 3. = The Village Council hereby determines (1) that the annexation will be to the best interest of the Village of Young America, Minn., and of the territory affected;

(2)- That the territory described herein abuts upon the Village and is so conditioned as properly to be subjected to Village Government.

Section 4. = Therefore, the Village of Young America Minnesota hereby ordains and declares that the property herein before described be and the same is hereby annexed to and included in the Village of Young America, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. = This Ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission the County Auditor and the Secretary of State, and from and after its passage and publication.
