IN THE MATTER OF THE PETITION OF THE VILLAGE OF EDINA AND THE CITY OF HOPKINS FOR THE SIMULTANEOUS DETACHMENT AND ANNEXATION OF CERTAIN PROPERTY DESCRIBED THEREIN UNDER LAWS 1959, CHAPTER 686, SECTION 6, SUBDIVISION 2 AS AMENDED.

QRDER

The Village of Edina has, by resolution of the Village Council at a meeting held on October 29, 1961, petitioned for the detachment of certain property hereinafter described, and the City of Hopkins has, at a meeting of the City Council held on November 21, 1961, petitioned to annex the same property, pursuant to Laws 1952, Chapter 686, Section 6, Subdivision 2 as amended.

The territory involved consists of:

"That part of the Northwest quarter (NW t) of Section 30, Township 117, Range 21, and of Blocks 5 and 6, "West Minneapolis Heights," described as follows: Commencing at the Northwest corner of said Section 30; thence East along the North line of said Section 30 to its intersection with the East line of Jefferson Avenue as dedicated in the plat of said "West Minneapolis Heights" extended to the North line of said Section 30, being the point of beginning of the tract of land to be described; thence South along said East line of said Jefferson Avenue and its extension to a point in the West line of Lot 26, Block 6, "West Minneapolis Heights," distant 30 feet North of the Southwest corner thereof; thence Easterly on a line 30 feet North of and parallel with the South lines of Lots 1 and 26, Block 6, and Lots 1 and 26, Block 5, said "West Minneapolis Heights", and the extensions of said lines, to the center line of Nonroe Avenue as dedicated in the plat of said "West Minneapolis Heights"; thence Northerly along the centerline of said Monroe Avenue to the North line of said Section 30; then Westerly along the North line of said Section 30; then Westerly along the North line of said Section 30 to the point of beginning."

All of the requirements of the statute having been met,

IT IS ORDERED: That the above described real property be, and hereby is, detached from the Village of Edina and annexed to the City of Hopkins, the same as if it had originally been a part thereof.
