ORDINANCE NO. 308

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN PLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES.

Section 1. A Petition has been filed with the governing body of the City of Montevideo, Minnesota, by the sole owner or all of the owners in number of the following described real estate to have such land included within the City of Montevideo, Minnesota:

Valgene A. Jorgenson	East One Half (E 1/2) Lot Eight (8) Block Two (2) Wolfe's Second Subdivision
Ernest Kittelson and Elnora Kittelson	East One-Half (E 1/2) Lot Nine (9) Block Two (2) Wolfe's Second Subdivision
Lamore D. Kittelson and Pauline Kittelson	East One-Half (E 1/2) Lot Ten (10) and the East One Half (E 1/2) Lot Eleven (11) Except the South Seventy (70) feet Wolfe's Second Subdivision
Evelyn P. Eddy	Sublot Seven (7) of Wolfe's First Subdivision

All in Section Six (6) Township One Hundred Seventeen (117)  
Range Forty (40) in Chippewa County, Minnesota

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is 1.90 acres.

Section 3. The City Council hereby determines that the annexation will be to the best interests of the City of Montevideo, Minnesota, and of the territory affected; that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

Section 4. Therefore, the City of Montevideo, Minnesota, hereby ordains and declares that the property hereinbefore described by and the same is hereby annexed to, and included in the City of Montevideo, Minnesota as effectually as if it had originally been a part thereof.

Section 5. This Ordinance shall be final and shall take effect and be in force from and after filing Certified copy thereof with the Minnesota Municipal Commission, the County Auditor and Secretary of State and from and after its passage and publication.
