AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN PLATTED LAND NOT EX-CEEDING TWO HUNDRED ACRES.

Section 1. Whereas the City of Montevideo is the owner in fee of those certain tracts of land described as follows, and which lands are situated outside of the corporate limits of said City of Montevideo, to-wit:

> Lots One (1) and Two (2) in Block Two (2); Lots one (1) and Two (2) in Block Three (3); Lots one (1) and Two (2) in Block Four (4) of Ira B. Wolfe Second Subdivision in the Southeast Quarter (SE 1/4) of the Southeast Quarter (SE 1/4) of Section Six (6), Township One Hundred Seventeen (117) Range Forty (40), and

A tract of land in the Southeast Quarter (SE 1/4) of Section Six (5), Township one Hundred Seventeen (117) Range Forty (40), described as follows:

Beginning at the intersection of the East line of Section Six (6) and the South line of the Montevideo Cemetery as now laid out, thence South along the East line of Section (Six (6) a distance of 12 rods, thence West parallel with the said South line of said Montevideo Cemetery a distance of 80 rods, thence at right angles North a distance of 12 rods to the South line of said Montevideo Cemetery as now laid out, and thence East along the South line of said Montevideo Cemetery to the point of the beginning, containing six (6) acres.

Section 2. The quantity of land embraced within the foregoing description and bounded as described is 9,/

Section 3. The City Council hereby determines that the annexation will be to the best interests of the City of Montevideo, and of the revritory affected, and is so conditioned as properly to be subjected to City government and control.

Section 4. Therefore, the City of Montevideo, Minnesota, hereby ordains and doctares that the property hereinbefore described by and the same is hereby annexed to, and included in the City of Montevideo, as effectually as if it had originally been a part thereof.

Section 5. This Ordinance shall be final and shall take effect and be in force from and after filing Certified copy thereof with the Minnesota Municipal Commission, the County Auditor and Socretary of State, and from and after its passage and publication.
