ORDINANCE NO. 150

An Ordinance Annexing Part of SWA of NEA of Section 29. Township 30 North, Rango 21 West. in Washington County, to the Village of Mahtomedi.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO ORDAIN AS FOLLOWS:

Section 1. That pursuant to that certain petition algority all of the owners of the land horoinafter described, in Washington County, Minnespeta, containing less than two hundred screet, abutting on the Easterly side of the Village of Mahtemedi, requesting the annountion of said land to said Village, said Petition having been duly filed with the Clerk of said Village; and it appearing that such annountion will be to the best interests of the Village and of the territory affected, the Village boundaries of the Village of Mahtemedi are hereby extended to include said land described by the following boundary lines:
