ORDINANCE NO. 165
AN ORDINANCE ANNEXING CER-
TAIN REAL ESTATE TO THE
CITY OF REDWOOD FALLS
THE CITY OF REDWOOD FALLS
DOES ORDAIN:

1. It is hereby found, determined, and declared that the real estate hereinafter described abuts upon the corporate limits of the City of Redwood Falls and is not included in any other municipality and that said real estate is so conditioned as properly to be subjected to municipal government.

2. It is hereby found, determined and declared that all of the owners of the real estate hereinafter described have duly executed and have filed in the office of the City Clerk, a petition praying that said real estate be annexed to the City of Redwood Falls and that said real estate does not exceed two hundred (200) acres.

3. It is hereby found, determined and declared that it will be to the best interests of the City of Redwood Falls and of the territory affected hereinafter described that the same be annexed to the City of Redwood Falls.

4. That the following described real estate lying and being in Redwood County, Minnesota, to wit: "Outlot 2 of Cedar Point Development" of the East 660 feet of the Southeast Quarter of the Northwest Quarter of Section 31, Township 113 North, Range 35 West, and Lot 8 of Subdivision 1 of Section 31, Township 113 North, Range 35 West, according to the plat thereof on file and of record in the office of the Register of Deeds in and for said County and State be and the same is hereby annexed to the City of Redwood Falls.
