AN ORDINANCE TO EXTEND THE BOUNDARIES OF THE VILLAGE OF SAINT RAPIDS AND INCORPORATE ADDITIONAL TERRITORY THEREIN

THE VILLAGE COUNCIL OF THE VILLAGE OF SAINT RAPIDS DOES ORDAIN:

Section 15:16. Village Boundaries Extended. Pursuant to a petition duly signed by all of the owners of the land in Benton County described as follows:


A tract of land described as the South half of the Southeast quarter of the Southeast quarter (S $\frac{1}{2}$ of SE $\frac{1}{4}$ of SE $\frac{1}{4}$), Section Fifteen (15), Township Thirty-six (36) North of Range Thirty-one (31) West of the Fourth Principal Meridian. Said tract containing 20 acres (more or less) and being platted as the Good Sheppard Lutheran Home of Saint Rapids, Minnesota.

The territorial limits of the Village are hereby extended to include such land within its limits, which shall hereafter be governed as other territory of the village is governed.

Section 15:17. Copies to be Filed. The Village Clerk shall forward a certificate of this ordinance to the Secretary of State and to the County Auditor for Benton County, Minnesota.


Section 15:18. Effect. Such land shall be annexed upon the filing of the certified copies hereof with the Secretary of State and the County Auditor.


