

Introduced by Alderman Christ Wilson

An Ordinance annexing certain lands to the City of Crookston.

Be it ordained by the City of Crookston as follows:

SECTION ONE

The City Council of the City of Crookston hereby finds, declares and determines that the sole owner of the property hereinafter described has petitioned the governing body of the City of Crookston, that said property be annexed to the City of Crookston; that said property is platted property not exceeding 200 acres; that said property does abutt the City of Crookston and is not included in any other municipality; that said property is described as:

Lots 187, 188, 189, 190, 191, 192, 193, 194, 195, 196, 197, 198, 199, 200, 201 and 202, NORCROSS ADDITION, Polk County, Minnesota, according to the official plat thereof on file and of record in the office of the Register of Deeds, Polk County, Minnesota.

That the annexation of said territory to the City of Crookston will be to the best interest of the municipality and to the territory affected.

SECTION TWO

That the property described as:

Lots 187, 188, 189, 190, 191, 192, 193, 194, 195, 196, 197, 198, 199, 200, 201 and 202, NORCROSS ADDITION, Polk County, Minnesota, according to the official plat thereof on file and of record in the office of the Register of Deeds, Polk County, Minnesota,

is hereby and the same is declared annexed to the City of Crookston and included therein as effectually as if it had originally been a part thereof.

SECTION THREE

This ordinance takes effect after its passage, approval and publication and after a certified copy thereof with the Minnesota Municipal Commission established under Section 414.01M.S., the County Auditor and the Secretary of State.
