

ORDINANCE NO. 117

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE VILLAGE OF OLIVIA.

The Council of the Village of Olivia do ordain as follows:

Section 1 - The following described property abutting upon the incorporated Village of Olivia, is hereby annexed to such village and shall become a part of such village as effectually as if it had originally been a part thereof:

Commencing at the southwest corner of Section 12, Township 115, Range 35, Renville County, Minnesota, thence northerly along the west line of said section to the south right-of-way line of U. S. Highway 212, thence easterly along the south right-of-way line of U. S. Highway 212 to a point which is 25 feet north of the northwest corner of Lot 9, Fairview Heights, Village of Olivia, thence southerly along the west line of Fairview Heights, Village of Olivia, to the south line of said Section 12, thence westerly along said south line to the place of beginning.

Section 2 - This ordinance shall be in full force and effect from and after the date of its publication.

RESOLUTION

At a duly called and held meeting of the Village Council of the Village of Olivia, Renville County, Minnesota, the matter of the annexation of land to the Village of Olivia came up for discussion. From the information available to the Council and upon the written petition of all of the owners of the lands herein-after described, it appears that said real estate is properly conditioned so as to be subjected to and benefited by municipal government and that the annexation as proposed will be to the best interests of the Village of Olivia and the prospective owners of said lands.

After discussion of said matter, Councilman Donnelly proposed the following resolution and moved its adoption, to-wit:

WHEREAS, a petition has been received to annex to the corporate limits of the Village of Olivia the following described property:

Commencing at the southwest corner of Section 12, Township 115, Range 35, Renville County, Minnesota, thence northerly along the west line of said section to the south right-of-way line of U. S. Highway 212, thence easterly along the south right-of-way line of U. S. Highway 212 to a point which is 25 feet north of the northwest corner of Lot 9, Fairview Heights, Village of Olivia, thence southerly along the west line of Fairview Heights, Village of Olivia, to the south line of said Section 12, thence westerly along said south line to the place of beginning; and

WHEREAS, the said lands are properly conditioned for administration by municipal government and it will be to the best interests of the Village of Olivia and the respective owners of said lands that said lands be annexed to the corporate village of Olivia,
