ORDINANCE NO. 152

An Ordinance Annexing Part of E 1/2 of
the SE 1/4 of Section 20, Township 30
North, Range 21 West, in Washington County,
to the Village of Mahtomedi.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO ORDAIN AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by all
of the owners of the land hereinafter described, in Washington County,
Minnesota, containing less than two hundred acres, abutting on the
Easterly side of the Village of Mahtomedi, requesting the annexation
of said land to said Village, said Petition having been duly filed
with the Clerk of said Village; and it appearing that such annexation
will be to the best interests of the Village and of the territory
affected, the Village boundaries of the Village of Mahtomedi are hereby
extended to include said land described by the following boundary lines:

The East One-half of the SE 1/4, Section 20, T30N, R21W,
described as follows: Beginning at the N.E. corner of
Lot 4, East Shore Garden Lots; thence East along the
North line of said Lot 4 produced a distance of 225 feet
to a point; thence south on a line parallel with the
East line of said Lot 4 a distance of 133.8 feet to a
point; thence west a distance of 225 feet to a point on
the East line of said Lot and 133.55 feet south of the
Point of Beginning; thence North along said East line a
distance of 133.55 feet to the Point of Beginning, ex-
cepting the westerly 25 feet thereof.

and that said territory is hereby made a part of the Village of Mah-
tomedi as effectually as if the same had originally been a part of
said Village.

Section 2. This Ordinance shall take effect and be in force
upon the filing of a certified copy thereof with the County Auditor
of Washington County and the Secretary of State of the State of
Minnesota and with the Minnesota Municipal Commission and from and
after its publication.
