

ORDINANCE NO. 95

VILLAGE OF FOLEY, DAKOTA COUNTY, MINNESOTA

AN ORDINANCE ADOPTING THE VILLAGE BOUNDARY

WHEREAS, all of the excess of the lands described below abutting upon said village have filed with the Village Clerk their petition setting forth said lands to the Village; and

WHEREAS, the Village Council of the Village of Foley has determined that the annexation of said lands to be in the best interest of the Village of Foley and of the territory affected thereby.

NOW, THEREFORE, THE VILLAGE COUNCIL OF THE VILLAGE OF FOLEY, MINNESOTA, DO ORDER AS FOLLOWS:

Section 1. That the Village boundaries of the Village of Foley are hereby extended so as to include the following described parcel of land abutting upon said village:

Beginning at the East Line of Boundary Avenue and its intersection with the South Right-of-Way Line of S. A. R. 26, Glyco Factory along said south right-of-way line a distance of 120.6 feet to a point, said point being the point of beginning. Thence continuing straight along said South Right-of-Way Line of S. A. R. 26 a distance of 120.3 feet to a point, thence south-easterly and parallel to Boundary Avenue a distance of 120.0 feet to a point, thence straight again to the last mentioned line, in a counter-clockwise direction, a distance of 120.0 feet to a point, thence to the right and parallel to said Boundary Avenue a distance of 120.0 feet to a point, said point being the point of beginning, lying in the Southwest Quarter (SW), Section Twenty-six (26), Township Thirty-four (34), Range Twenty-nine (29). For title to said land to be the acre of Charlotte F. Goldridge, a widow, and occupied by Charlotte Adeline Conigliari, Italian Church, a religious corporation under the laws of the State of Minnesota, under a lease for land from said Charlotte F. Goldridge.

Section 2. That none of the real estate described above is platted and that the total area of said real estate do less than 200 acres, and in fact is less than five acres, and that the annexation of said lands to the village herein shall be deemed complete upon the publication of said ordinance and the recording of the said ordinance with the Register of Deeds and the filing of a certified copy thereof with the County Auditor, Secretary of State and the Minnesota Historical Foundation and the approval of same by said Foundation.

Passed at a regular meeting of the Village Council held on the twentieth day of December, 1962.
