

ORDINANCE NO. 95

VILLAGE OF FOLEY, DISTRICT COUNTY, MINNESOTA

#16034

AN ORDINANCE EXTENDING THE VILLAGE BOUNDARIES

WHEREAS, all of the owners of the lands described below abutting upon said village have filed with the Village Clerk their petitions asking that said lands be annexed to the Village; and

WHEREAS, the Village Council of the Village of Foley has determined that the annexation of said lands is in the best interest of the Village of Foley and of the territory affected thereby.

NOW, THEREFORE, THE VILLAGE COUNCIL OF THE VILLAGE OF FOLEY, MINNESOTA, DO ORDAIN AS FOLLOWS:

Section 1. That the Village boundaries of the Village of Foley are hereby extended so as to include the following described parcel of land abutting upon said village:

Commencing at the East line of Broadway Avenue and its intersection with the South Right-of-way line of S. A. R. 36; thence Easterly along said South Right-of-way line a distance of 120.6 feet to a point, said point being the point of beginning; thence continuing Easterly along said South Right-of-way line of S. A. R. 36 a distance of 150.3 feet to a point; thence South-easterly and parallel to Broadway Avenue a distance of 122.0 feet to a point; thence at right angles to the last mentioned line, in a southeasterly direction, a distance of 140.0 feet to a point; thence to the right and parallel to said Broadway Avenue a distance of 222.0 feet to a point, said point being the point of beginning, being in the Southeast Quarter (24), Section Twenty-nine (29), Township Thirty-seven (37), Range Twenty-nine (29). For title to said land is in the name of Charlotte T. Haldridge, a widow, and occupied by Gustavus Adolphus Evangelical Lutheran Church, a religious corporation under the laws of the State of Minnesota, under a leasehold for good from said Charlotte T. Haldridge.

Section 2. That none of the real estate described above is platted and that the total area of said real estate is less than 200 acres, and in fact is less than five acres, and that the annexation of said lands to the Village limits shall be deemed complete upon the publication of said ordinance and the recording of the said ordinance with the Register of Deeds and the filing of a certified copy thereof with the County Auditor, Secretary of State and the Minnesota Municipal Commission and the approval of same by said Commission.

Passed at a regular meeting of the Village Council held on the seventh day of November, 1962.
