## ORDINANCE NO. 189

AN ORDINANCE AMENDING ORDINANCE NO. 179 RELATING TO THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF ALEXANDRIA, MINNESOTA, DECLARING THE WARDS TO WHICH IT SHALL BE ATTACHED, AND EXTENDING THE CORPORATE LIMITS TO ENCOMPASS SAID LAND.

The City Council of the City of Alexandria does ordain:

SECTION I

Section II of Ordinance No. 179 shall be amended to read as follows:

"That the following described land, to wit: That part of the Northeast Quarter of the Northwest Quarter of Section 30, Township 128, Range 37, described as follows: Beginning at a point 576 feet west of the southeast corner of said northeast quarter of the Northwest Quarter, thence west along the forty line 284 feet; thence north 98.8 feet to the southeasterly right of way limits of T.H. No. 29; thence in a northeasterly direction for twenty two and five tenths (22.5) feet along the said southeasterly right of way limits; thence east 267.7 feet; thence south 115 feet to the point of beginning, said tract containing 0.747 acres more or less; AND that part of the Northeast Quarter of the Northwest Quarter, Section 30, Township 128, Range 37, described as follows: Beginning at a point 860 feet west along the forty line from the Southeast Corner of the Northeast Quarter of the Northwest Quarter; thence west and along the forty line to the Southeasterly right of way of trunk highway 29; thence in a Northeasterly direction along said right of way line to a point 98.8 feet north of the point of beginning; thence south 98.8 feet to the point of beginning, said tract containing 0.112 acres more or less

is hereby annexed to and made a part of the municipality of the City of Alexandria, and the corporate limits of the City of Alexandria, Minnesota shall be and hereby are extended to include and encompass the land and territory above described."

SECTION II

This ordinance shall be in full force and effect from and after its passage and publication.
