JOHN C. HAAVE ATTURNEY-AT-LAW INTEVIDED, MINNESOTA AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MONTENIDED TO INCLUDE CERTAIN U.S. PLATTED LANDS.

MMEREAS, the City of Montovideo is the owner in fee of those certain tracts and parcols of land hereinsfter described and the City Council having determined that the annexation of said tracts will be to the best interests of the City of Montevideo,

MOV THEREPORE, the City of Montovideo does ordain as follows:

That the following described tracts and parcols of land lying and being in the County of Chippewn, State of Minnesota, to-wit:

> Parcel 1: Beginning at a point 33 feet west of the Southeast corner of the W 1/2 SE 1/4 of Section 6. Township 117, Range 40; thence continue west along the south line of said N 1/2 SE 1/4 a distance of 1250 feet; thence northeasterly on a straight line to a point on the north line of said N 1/2 SN 1/4 that is 733 feet west from the east line of said N 1/2 SN 1/4; thence east 700 feet; thence south on a line that is 33 feet west of and parallel to the east line of said N 1/2 SE 1/4 a distance of 1328 feet to point of beginning, containing 29 3/4 acres.

Parcel 2: Beginning at a point 33 feet west and 20 feet north from the southeast corner of the SE 1/4 NE 1/4 of Section 6, Township 117, Range 40; thence north along a line that is 33 feet west of and parallel to the east line of said SE 1/4 NE 1/4 a distance of 266 feet; thence west 724 feet; thence south 274 feet to a point that is 20 feet north from the south line of said SE 1/4 NE 1/4; thence east on a line that is 20 feet north of and perallel to the south line of said SE 1/4 NE 1/4 a distance of 736 feet to the point of beginning.
