CHAPTER NO. 313

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF
THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN UN-
PLATTED LANDS.

WHEREAS, the City of Montevideo is the owner in fee of those
certain tracts and parcels of land hereinafter described and the City Council
having determined that the annexation of said tracts will be to the best in-
terests of the City of Montevideo,

NOW THEREFORE, the City of Montevideo does ordain as follows:

SECTION 1. That the following described tracts and parcels of
land lying and being in the County of Chippewa, State of Minnesota, to-wit:

Parcel 1: Beginning at a point 33 feet west of the Southeast
corner of the N 1/2 SE 1/4 of Section 6, Township 117, Range 40;
thence continue west along the south line of said N 1/2 SE 1/4
a distance of 1250 feet; thence northeasterly on a straight
line to a point on the north line of said N 1/2 SE 1/4 that is
733 feet west from the east line of said N 1/2 SE 1/4; thence
east 700 feet; thence south on a line that is 33 feet west of
and parallel to the east line of said N 1/2 SE 1/4 a distance
of 1325 feet to point of beginning, containing 29 3/4 acres.

Parcel 2: Beginning at a point 33 feet west and 20 feet north
from the southeast corner of the SE 1/4 NE 1/4 of Section 6, Town-
ship 117, Range 40; thence north along a line that is 33 feet west
of and parallel to the east line of said SE 1/4 NE 1/4 a distance
of 266 feet; thence west 724 feet; thence south 274 feet to a
point that is 20 feet north from the south line of said SE 1/4
NE 1/4; thence east on a line that is 20 feet north of and per-
allel to the south line of said SE 1/4 NE 1/4 a distance of 736
feet to the point of beginning. Containing 4 1/2 acres.

Parcel 3: The North one-half of the southwest one-quarter
N 1/2 SW 1/4 of Section 5, Township 117, Range 40, and the
south one-half of the northwest one-quarter (S 1/2 NW 1/4) of
Section 5, Township 117, Range 40.

be, and the same hereby are, annexed to the City of Montevideo and included
within the corporate limits thereof as a part of the commercial district of
the said City of Montevideo as effectually as if it had been originally part
thereof, and excepting therefrom, however, the right-of-way of Trunk High-
way No. 29 as now located across said tracts and parcels of land.

SECTION 2. This Ordinance shall be in full force and effect after
its passage, adoption and publication as by the Charter of the City of Monte-
video provided.
