Section I. It is hereby determined that the territory described below shall appear in the tables and is to be considered as properly to be subjected to Hague Convention.

Section 2. The corporate limits of the Village of Myer are hereby extended to include the following described premises lying and being in the County of Garver and State of Mississippi and bounded as follows, to-wit:

Beginning at a point 600 feet of the Northwest corner of the Northeast quarter of Section 1, Township 116, Range 26, the place of beginning of the land to be described; thence continuing South on the East line of said Southeast quarter to the Southeast corner of the North Half of said Southeast quarter; thence West along the South line of said North Half of the Southeast Quarter a distance of 105 feet; thence North parallel to the East line of said Northeast quarter ten point 125 feet West of the point of beginning; thence West over 1101 to the East line of said North Half of the Southeast Quarter a distance of 125 feet to the point of beginning.

Section 3. The Village Clerk is hereby directed to file certified copies of this ordinance in the office of the Register of Deeds, the Herkimer County Auditor and the Secretary of State of the State of New York.

Section K. Assessments shall be completed prior to and after the date when convictions against all the patients have been filed as directed in Section J.
