AN ORDINANCE ESTABLISHING THE CORPORATE LIMITS OF THE VILLAGE OF HAYES, HARVER COUNTY, MINNESOTA BY EXTENDING SAID LIMITS TO THE NORTHWEST CORNER OF SECTION 20

Whereas, a certain petition dated December 4, 1962, requesting annexation of the territory described below was duly presented to the Council on the 11th day of December, 1962,

and whereas it appears that said petition is proper,

The Council of the Village of Hayes, Harver County, Minnesota ordains:

Section 1. It is hereby determined that the territory described below shall upon the Village and is so conditioned as properly to be subjected to Village Government.

Section 2. The corporate limits of the Village of Hayes are hereby extended to include the following described parcels lying and being within the County of Harver and State of Minnesota and described as follows, to-wit:

Commencing at a point 629 feet south of the Northwest corner of the Southeast quarter of Section 1, Township 116, Range 26, the place of beginning of the land to be described; thence continuing south on the East line of said Southeast quarter to the Southeast corner of the North Half of said Southeast quarter; thence West along the South line of said North Half of the Southeast quarter a distance of 125 feet; thence North parallel to the East line of said Southeast quarter ten point 125 feet West of the point of beginning; thence West parallel to the South line of said North Half of the Southeast quarter a distance of 125 feet to the point of beginning.

Section 3. The Village Clerk is hereby directed to file certified copies of this ordinance in the office of the Commission of Legislation, the Harver County Auditor and the Secretary of State of the State of Minnesota.

Section 4. Annexation shall be complete from and after the date when certified copies of this ordinance have been filed as directed in Section 3.
