Providing For The Annexation of Property

Introduced by Councilman Ronald Blakeslee

WHEREAS, a petition has been filed with the City Council requesting the annexation of the following described property abutting on the City and containing 15.7 acres, to the City of Albert Lea, said petition containing the signatures of a majority of owners in the area, and,

WHEREAS, the City Council of the City of Albert Lea does determine that it will be to the best interests of the City of Albert Lea and said property to annex the same to the City, pursuant to Laws 1959, Chapter 686, Sec. 3, Sub 7:

WHEREAS in accordance with Minn. Statutes the City Council has set and held a hearing on the proposed annexation on December 10, 1962,

THE CITY OF ALBERT LEA DOES ORDAIN:

Sec. 1. The following described property, viz:

Block 1 Edina Manor - Lots 1 to 9 inclusive; lot 12; Lot 14 less the south 10 feet; the south 10 feet of lot 15; Lots 16 and 17; the south 20 feet of Lot 18; Lots 19 and 20.

Block 6 Edina Manor - Lots 1 to 6 inclusive.

Block 7 Edina Manor - Lots 1 to 8 inclusive; and that portion of Ninth Street vacated south of and adjoining lot 8 in Block 7 Edina Manor; the west 27.5 feet of the north 20 feet of lot 14 and the west 27.5 feet of Lots 15 and 16.

Block 10 Edina Manor - Lots 1 to 4 inclusive and that portion of Lot 7 lying west of a line drawn from the northeast corner of Lot 2 to the south line of Ninth Street vacated.

Also all portions of Seventh Street, Eighth Street, James Avenue, and St John Avenue abutting upon the above described lots to be annexed and all that portion of T.H. 65 lying in the Southwest 1/4 Section 16-102-21.

as included in the above mentioned petition is so conditioned as property to be subjected to city government is hereby declared to be an addition to the City of Albert Lea as effectually as if it had been originally a part thereof.

Sec. 2. The above described property is hereby designated as C-2 General Commercial classification zoning and shall be so indicated on the zoning district map.

Sec. 3. This annexation shall be deemed effective upon the filing of copies of the ordinance with the Municipal Commission, the County Auditor and the Secretary of State and the effective date of the ordinance shall be January 10, 1963.
