

ORDINANCE NO. 335

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF WASECA, MINNESOTA, THE COMMON COUNCIL OF THE CITY OF WASECA DO ORDAIN:

SECTION 1. WHEREAS, the City of Waseca has been shown to be owner of a portion of the under described property, and all of the owners of all of the remaining property described hereinafter have petitioned the Common Council of the City of Waseca to have said property annexed to the City of Waseca, said property lying and being in the County of Waseca and State of Minnesota, and described as follows, to-wit:

All that parcel and tract of land, lying and being in the County of Waseca and State of Minnesota, and described as follows: Commencing at a point on the East line of 5th Street S. W. Five Hundred Twenty-One and Ninety-Hundredths (521.90) feet South of the Southwest corner of Lot Two (2), Block Two (2), R. P. Ward's Addition to the City of Waseca, said point also being described as the intersection of the East line of the said 5th Street S. W. and the extended South line of Lot Eight (8), R. P. Ward's Subdivision "A" to the said City and State; thence South along the said East line of 5th Street S. W. Six Hundred Sixty (660) feet more or less to a point on the extended South line of Lot Eighteen (18) of R. P. Ward's Subdivision "A"; thence East One Hundred Ninety (190) feet more or less on the said extended South line of said Lot Eighteen (18) to the Southwest corner of said Lot Eighteen (18); thence North on the West line of said R. P. Ward's Subdivision "A" Six Hundred Sixty (660) feet more or less to the Southwest corner of Lot Eight (8) of said R. P. Ward's Subdivision "A"; and thence West One Hundred Ninety (190) feet more or less on the extended South line of said Lot Eight (8) to the point of beginning; together with Lots Fourteen, Fifteen, Sixteen, Seventeen and Eighteen (14, 15, 16, 17, 18) in R. P. Ward's Subdivision "A" to the City of Waseca and together with the West One-Half (W $\frac{1}{2}$ ) of 4th Street S. W. opposite Lots Fourteen, Fifteen, Sixteen, Seventeen, Eighteen and Nineteen (14, 15, 16, 17, 18, 19) in R. P. Ward's Subdivision "A" to the City of Waseca, all according to the Plat thereof on file and of record in the office of the Register of Deeds in and for said County and State.

AND WHEREAS, it has been shown that said land is either owned by the said City of Waseca or owned by petitioners who have all signed the said petition, and that all of the said land is platted and is completely surrounded by land within the municipal limits of the City of Waseca and that all of said land is contiguous to the City limits of the City of Waseca;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF WASECA, MINNESOTA, pursuant to the authority and provisions of Section 414.03, Subdivision 2, Minnesota Statutes Annotated:

SECTION 2. That said real estate, described hereinbefore, be, and the same hereby is, annexed to the City of Waseca, Minnesota.

SECTION 3. That a duly certified copy of this ordinance shall be filed with the Minnesota Municipalities Commission, the Waseca County Auditor, the Secretary of the State of Minnesota, and that a certified copy of this ordinance shall be filed and recorded in the office of the Register of Deeds of Waseca, Minnesota.

SECTION 4. This Ordinance shall take effect and be in force from and after its publication in accordance with law.
