Application for the Retirement of Frank T. Gallagher, Associate Justice of the Supreme Court of the State of Minnesota, under the Provisions of Minnesota Statutes 490.025 and the laws of the State of Minnesota in such cases made and provided.

To the Honorable Elder L. Anderson, Governor of the State of Minnesota.

The undersigned Frank T. Gallagher, Associate Justice or Associate Judge of the Supreme Court of the State of Minnesota, hereby makes written application for his retirement effective from the office of Associate Justice or Associate Judge of said Court under the provisions of Minnesota Statutes 490.025 and the laws of the State of Minnesota in such cases made and provided.

Said application is based upon the following facts, to-wit:

That said applicant was born on July 13th, 1887, as evidenced by the certified copy of his birth certificate attached hereto, marked Exhibit "A", and reached the age of 70 years on July 13th, 1957, and the age of 75 years on July 13th, 1962.

That said applicant was first elected to the office of Associate Justice of the Supreme Court of the State of Minnesota at the general election in said state on the 5th day of November, 1946; that he took the oath of office and was sworn in as an Associate Justice of said Court on the 6th day of January, 1947, and has served continuously as an Associate Justice or Associate Judge of said Court since that date; that he has served as an Associate Justice or Associate Judge of said Court for two full terms and is now serving in the fourth year of his third continuous term.

That the files and records of the State of Minnesota incorporated herein by reference establish the above referred to facts as to the dates when the undersigned applicant was first elected, when he was first sworn in and the period of his continuous service as an Associate Justice or Associate Judge of said Court.

Wherefore the undersigned respectfully requests that you, Elmer L. Anderson, Governor of the State of Minnesota, find that the said Frank T. Gallagher is qualified for retirement as an Associate Justice or Associate Judge of the Supreme Court of the State of Minnesota under the provisions of Minnesota Statutes 400.085 and the laws of the State of Minnesota in such case made and provided, and that you forthwith direct by written order the retirement of the undersigned in conformity with the laws of the State of Minnesota in such case made and provided, effective

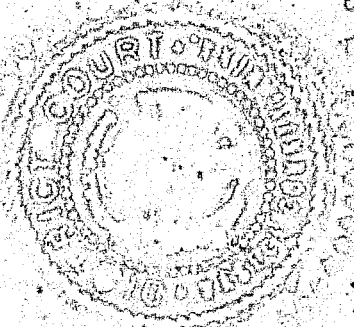
