ORDINANCE NO. 285

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF
THE CITY OF MARSHALL TO INCLUDE CERTAIN UN-
INCORPORATED PROPERTY OWNED BY AND ABUTTING
UPON THE LIMITS OF THE CITY

WHEREAS, the territory described below is not presently within
the corporate limits of any incorporated city, village, or borough; and

WHEREAS, said territory abuts upon the corporate limits of the
City of Marshall at the northwesterly & westerly boundary thereof and is
deemed to be urban in character; and

WHEREAS, said territory is owned in fee by said City;

The Common Council of the City of Marshall do ordain as follows:

Section 1. Territory Annexed. The corporate limits of the City of
Marshall are hereby extended to include the unplatted property located
in the County of Lyon, State of Minnesota, and described as follows now
owned by said City:

All that part of the Southeast Quarter ($SE\frac{1}{4}$) of the Southwest
Quarter ($SW\frac{1}{4}$) of Section 32, Township 112 North, Range 41 West,
described as follows: Commencing at the South quarter corner
of said Section 32, which is point of beginning, thence Westerly
along South section line of said Section 32, on an assumed
bearing of North 89 degrees, 58 minutes, 30 seconds West, a
distance of Eight Hundred Thirty-One and Seven Tenths (831.7)
feet, thence North 44 degrees, 30 minutes East a distance of
Six Hundred Thirty (630) feet to a point on the Southwesterly
right-of-way line of the Chicago and Northwestern Railroad,
thence in a Southeasterly direction along said right-of-way
line of said railroad to a point on the North and South quarter
line of said Section 32, thence Southerly along said quarter
line to a point Thirty-three (33) feet North of the South quarter
corner of said Section 32, thence Westerly and parallel to said
South section line a distance of Thirty (30) feet, thence in a
Southeasterly direction and parallel to center line of said
railroad to a point on the North and South quarter line of
said Section 32, thence Southerly on said quarter line to point
of beginning.

Also that part of the East One Half ($E\frac{1}{2}$) of the Northwest Quarter
($NW\frac{1}{4}$) of Section 5, Township 111 North, Range 41 West, described
as follows: Commencing at the North one quarter corner of said
Section 5, which is point of beginning; thence Westerly along
North section line of said Section 5 a distance of Seven Hundred
Thirty-nine and Two Tenths (739.2) feet, thence South 44 degrees,
30 minutes West a distance of Two Hundred Thirty-three and Twenty-
four One Hundredths (233.24) feet, thence North 45 degrees 30
minutes West a distance of One Hundred (100) feet, thence at
right angles left, thence left on a curve of Sixteen Hundred
Seventy and Seventy-six One Hundredths (1670.76) foot radius
to point on the North and South One Sixteenth ($1/16$) line of
the Northwest Quarter ($NW\frac{1}{4}$) of said Section 5, thence South
along said One Sixteenth ($1/16$) line to the South One Sixteenth
($1/16$) corner of the Northwest Quarter ($NW\frac{1}{4}$) of said Section 5,

thence Easterly along the East and West quarter line of said Section 5 a distance of Four Hundred Eighty-six and Fifty-five One Hundredths (486.55) feet, thence North 5 degrees, 30 minutes East a distance of Fourteen Hundred Eighty (1480) feet, thence right on a curve of Eight Hundred Seventy and Seventy-six One Hundredths (870.76) foot radius a distance of Five Hundred Ninety-two and Seventy-one One Hundredths (592.71) feet, thence North 45 degrees, 30 minutes West a distance of One Hundred (100) feet, thence North 44 degrees, 30 minutes East to a point on the North and South quarter line of said Section 5, thence Northerly along said quarter line to a point of beginning.

Section 2. Filing. The City Recorder is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of Lyon County, State of Minnesota, and the Minnesota Municipal Commission.

Section 3. Effective Date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in section 2.
