

AN ORDINANCE AMENDING THE ADMINISTRATION OF GOVERNMENT AND TO REGULATE THE PUBLIC INTERESTS OF THE CITY OF STILLWATER AND OF THE TERRITORY AFFORED AND DECLARING SAME TO BE ANNEXED TO THE CITY

THE COUNCIL OF THE CITY OF STILLWATER DO ORDEA AS FOLLOWS:

SECTION 1. The following territory, consisting of platted and unplatte land not exceeding two hundred (200) acres in all, abutting upon the City of Stillwater, Washington County, Minnesota, being so conditioned as properly to be subject to municipal government and not devolved in any other municipality, upon petition of all the owners in number, and in the first instance of the City of Stillwater and of said territory, is hereby declared to be annexed to the said City, to-wit:

Beginning at the Northeast corner of the Northwest quarter of the Southeast Quarter of Section 38, in Township 30 North of Range 20 West, being at the intersection of the present South Boundary line of said City with the center line of Hazel Street in the plat of McFertry's Addition to Stillwater and Webster's Third Addition to Stillwater, Minnesota, on file and of record in the office of the Register of Deeds of said County, and running thence South along the East line of said quarter-quarter section, being the center line of said Hazel Street, to the center line of Grove Street; thence West along said center line of Grove Street to the West line of Lot 3 in Block 14 of said McFertry's Addition to Stillwater extended North; thence South along said last described line to the Southwest corner of said Lot 3; thence East along the South line of Lots 3, 2, and 1 in said Block extended East to said center line of Hazel Street; thence South along said center line of Hazel Street to the Southeast corner of said quarter-quarter section; thence West along the South line of said quarter-quarter section, being the center line of Prairie Street, to the center line of Birch Street; thence North along said center line of Birch Street to the center line of Grove Street; thence West along said center line of Grove Street to the center line of South Third Street; thence North along said center line of South Third Street to the center line of St. Croix Street; thence East along said center line of St. Croix Street to the center line of South First Street; thence North along said center line of South First Street to the intersection thereof with the South line of Lot 9 in Block 1 of said Webster's Third Addition to Stillwater, extended West; thence East along said last described line to a point 70 feet East of the Southwest corner of said Lot 9; thence North parallel with the West line of said Block 1 to the North line of said quarter-quarter section, being the South boundary line of said City as aforesaid; thence East along said last described line to the point of beginning; all of said streets being situated in the aforesaid plat, respectively.

SECTION 2. The above described territory shall be incorporated in and become a part of the First Ward, First Precinct, of the City for election purposes until otherwise designated by the City Council as provided by law.
