AN ORDINANCE EXTENDING THE CORPORATE LIMITS  
OF THE SAID CITY OF MONTEVIDEO TO INCLUDE  
CERTAIN PLATTED LAND NOT EXCEEDING TWO HUNDRED  
ACRES

WHEREAS the City Council of the City of Montevideo, Minnesota on  
the 20th day of November, 1962, passed and adopted a Resolution giving Notice  
that the City Council intended to annex platted tracts of land lying within  
the municipal limits of said City of Montevideo which platted tracts of land  
are described as follows:

The West Half (W 1/2) of Lot Eight (8); the North Half  
(N 1/2) of the West Half (W 1/2) of Lot Nine (9); the  
South Half (S 1/2) of the West Half (W 1/2) of Lot Nine  
(9) and the North Half (N 1/2) of the West Half (W 1/2)  
of Lot Ten (10) all in Block Two (2) of Ira S. Wolfe's  
2nd Subdivision in the Southeast Quarter of the South-  
east Quarter (SE 1/4, SW 1/4) in Section Six (6) Township  
One Hundred Seventeen (117) Range Forty (40) Chippewa  
County, Minnesota,

and giving notice that a public hearing upon such annexation will be held  
before the City Council of the City of Montevideo, Minnesota on Monday, the  
3rd Day of December, 1962 at 8:00 o'clock P. M. and which notice of such  
public hearing was duly served upon all the owners of said platted tracts of  
land and such public hearing having been held at the time and place in said  
Resolution specified, and no one appearing at said hearing in opposition  
thereto,

The quantity of land embraced within the foregoing description  
and bounded as described is 0.8 acres.

The City Council having determined and does hereby determine that  
the annexation will be to the best interests of the City of Montevideo, Min-  
nesota and of the territory affected.

That the territory described is completely surrounded by lands  
within the corporate limits of said City of Montevideo and so conditioned  
as to be properly subject to City Government and Control.

NOW THEREFORE, the City of Montevideo, Minnesota hereby ordains  
and declares:

SECTION 1. That the property hereinbefore described be and the same  
hereby is annexed to and included in the City of Montevideo, Minnesota as ef-  
fectively as if it had originally been part thereof.

SECTION 2. This Ordinance shall be final and shall take effect on  
its passage and publication as by the Charter provided and be in force from  
and after the filing of the certified copy thereof with the Minnesota Municipal  
Commission, the Secretary of State, the County Auditor and the Register of  
Deeds of Chippewa County, Minnesota
