ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MANKATO TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES, PURSUANT TO CHAPTER 686, LAWS OF MINNESOTA, 1959 SESSION.

The City of Mankato, Minnesota doos ordain:

## Section 1.

A petition has been filed with the City Clork of the City of Mankato, Minnesota by Mankato Clinic Building Company, a corporation, sole owners of the following described real estate to have such land included within the City of Mankato, Minnesota, to-wit:

Commencing at the Northeast corner of the Northeast Quartor of Section Seventeen, Township One Hundred Eight, Rango Twenty-six, thence South 80 rods, thence West 12 rods, thence North 80 rods, thence East 12 rods to the place of beginning, containing 6 acres of land more or less.

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State, and this ordinance takes effect 10 days after its passage and publication and the filing of certified copies, as herein described.
