

ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF MANKATO TO INCLUDE CERTAIN
UNPLATTED LAND NOT EXCEEDING TWO HUNDRED
ACRES, PURSUANT TO CHAPTER 686, LAWS OF
MINNESOTA, 1959 SESSION.

The City of Mankato, Minnesota does ordain:

Section 1.

A petition has been filed with the City Clerk of the City of Mankato, Minnesota by Mankato Clinic Building Company, a corporation, sole owners of the following described real estate to have such land included within the City of Mankato, Minnesota, to-wit:

Commencing at the Northeast corner of the Northeast Quarter of Section Seventeen, Township One Hundred Eight, Range Twenty-six, thence South 80 rods, thence West 12 rods, thence North 80 rods, thence East 12 rods to the place of beginning, containing 6 acres of land more or less.

The East Half of the West 8 acres of the East 14 acres of the Northeast Quarter (NE $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$) of Section 17, Township 108 North, Range 26 West, excepting therefrom highway easements for existing highways.

Section 2.

The quantity of land embraced within the foregoing description is unplatted and does not exceed 200 acres and is not within the corporate limits of any city or village and is contiguous to and abutting upon a portion of the easterly boundary of the City of Mankato, Minnesota, an incorporated city, having a population of not less than 10,000 nor more than 30,000, pursuant to the last census.

Section 3.

The City Council of Mankato, Minnesota hereby determines that the annexation of the above described property will be to the best interests of the municipality and of the land affected and that the above described tract and parcel of land is so conditioned as properly to be subjected to city government and is hereby annexed to and declared to be an addition to the City of Mankato, as effectually as if it had originally been a part thereof and the corporate limits of the City of Mankato, Minnesota are hereby extended to include said property.

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State, and this ordinance takes effect 10 days after its passage and publication and the filing of certified copies, as herein described.




