AN ORDINANCE ANNEXING CERTAIN REAL ESTATE TO THE CITY OF REDWOOD FALLS

THE CITY OF REDWOOD FALLS DOES ORDAIN:

1. IT IS HEREBY FOUND, determined and declared that the real estate hereinafter described abuts upon the corporate limits of the City of Redwood Falls, is not included in any other municipality, and that certain real estate is so considered as properly to be subjected to municipal government.

2. It is hereby found, determined and declared that all of the owners of the real estate hereinafter described have duly executed and have filed in the office of the City Clerk a petition praying that said real estate be annexed to the city of Redwood Falls, and that said real estate does not exceed two hundred (200) acres in area.

3. It is hereby found, determined and declared that it will be to the best interests of the City of Redwood Falls and of the territory affected hereinafter described that the same be annexed to the city of Redwood Falls.

4. That the following described real estate lying and being in Redwood County, Minnesota, to wit:

All that part of the Northeast Fractional Quarter (NEFr $\frac{1}{4}$) of Section Six (6), Township One Hundred Twelve (112) North, Range Thirty Five (35) West, described as follows:

Beginning at a point 703.4 feet South of the North Quarter (N $\frac{1}{4}$) corner of said Section Six (6); thence in a Southerly direction along the West line of the Northeast Fractional Quarter (NEFr $\frac{1}{4}$) of said section a distance of 1015.50 feet; thence in an easterly direction a distance of 419.33 feet; thence North 23 degrees 59 minutes West a distance of 575.23 feet; thence in a Northerly direction a distance of 489.93 feet; thence in a Westerly direction a distance of 180.00 feet to the place of beginning, containing 5.64 acres, more or less,

be, and the same is hereby annexed to the City of Redwood Falls.
