AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE VILLAGE OF ISANTI, ISANTI COUNTY,
MINNESOTA, TO INCLUDE UNPLATTED LAND NOT
EXCEEDING 200 ACRES IN AREA.

MHEREAS a cortain Fatition requesting annoxation of the torritory described below was duly presented to the Council on the 31st day of January, 1963, and

WHEREAS said Fotition was duly signed by the solo owners of said territory:

THE VILLAGE COUNCIL OF ISANTI ORDAINS:

- 1. Section 1. Declaration. It is hereby determined that the territory described below abutto upon the Village and is so conditioned as properly to be subjected to Village government.
- 2. <u>Section 2. Torritory Amnexed.</u> The corporate limits of the Village are hereby extended to include the territory described as Collovs:

That part of the Northeast Quarter of Southwest Quarter (NEt of SWt), Section 29, Township 35, Range 23, described as follows, to-wit: Beginning at the intersection of the North right-of-way line of the public town road as presently existing and laid out, said road being the extension of Broadway Street in the Village of Isanti, Minnosota, with the West line of said Northeast Quarter of Southwoot Quarter, said intersection being 33 feet North of the Southwest corner of said Northeast Quarter of Southwest Quarter, thence Bact and along said North right-of-way line of said road, and parallel to the South line of said Wortheast Quarter of Southwest Quartor a distance of 670.25 feet to the West right-of-way line of Minnesota Trunk Highway No. 65 as presently existing and laid out, thence Wortheasterly along said West right-of-way line of Highway No. 65 a distance of 198.5 foot more or loss, to the intersection of said West right-of-way line of Highway No. 65, with the South, right-of-way line of the public read as presently existing and laid out, said road boing the extension of Main Street in the Village of Idanti, Minnocota, thonco Westerly along said South right-of-way line of said Wain Stroot as extended Easterly to said Highway No. 65, a distance of 697.87 feet to the intersection of said South right-of-way line with the West line of said Worthoast Quarter of Southwest Quarter, thonce South and
