

ORDINANCE NO. 174

AN ORDINANCE TO EXTEND THE BOUNDARIES OF THE VILLAGE OF SAUK RAPIDS AND INCORPORATE ADDITIONAL TERRITORY THEREIN.

THE VILLAGE COUNCIL OF THE VILLAGE OF SAUK RAPIDS DOES ORDAIN:

Section 15:22. Village Boundaries Extended. Pursuant to a petition duly signed by the owners of the land in Benton County described as follows:


That part of the Southwest Quarter (SW $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section 24 - 36N - 31W in Benton County Minnesota described as follows: Beginning at the Northwest corner of the Southwest Quarter (SW $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of said Section 24 running thence South 86.2 feet to the centerline of First Street South thence North 89°25' East along said center line for a distance of 240 feet to the point of beginning; continuing thence along said center line for the distance of 215.53 feet; thence south parallel to the West line of said Southwest Quarter (SW $\frac{1}{4}$) 198 feet; thence south 89°25' West parallel to said center line 215.53 feet; thence North 198 feet to the point of beginning and there terminating, said tract containing 1.98 acres more or less and to be known as Lots 1, 2 and 3, FIRST HIGH SCHOOL ADDITION.

The territorial limits of the Village are hereby extended to include such land within its limits, which shall be hereafter governed as other territory of the village is governed.

Section 15:23. Copies to be filed. The Village Clerk shall forward a certificate of this ordinance to the Secretary of State and to the County Auditor for Benton County, Minnesota.


Section 15:24. Effect. Such land shall be annexed upon the filing of the certified copies hereof with the Secretary of State and the County Auditor.


