

ORDINANCE # 95

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF
THE VILLAGE OF WAITE PARK TO INCLUDE CERTAIN PLATTED LAND

The Council of the Village of Waite Park, Minnesota, ordain:

Section 1. A Petition has been filed with the Governing body of the Village of Waite Park, Minnesota, by the sole owner of the following described real estate to have such land included within the Village of Waite Park, Minnesota.

Lots numbered Three and Four (3 & 4), in Block numbered Thirteen (13), in Oakdale, a Subdivision in Section Numbered Sixteen (16), Township Numbered One Hundred Twenty-four (124) North of Range Numbered Twenty-eight (28) West, according to the plat and survey thereof now on file and of record in the office of the Register of Deeds in and for the County of Stearns and the State of Minnesota.

Section 2. The Village Council hereby determines:

- a. That the annexation will be to the best interests of the Village of Waite Park, Minnesota and of the territory affected.
- b. That the territory described herein abutts upon the Village and is so conditioned as properly to be subjected to Village Government.

Section 3. The Corporate limits of the Village of Waite Park are hereby extended to include the property described in Section 1, and the same is hereby annexed to and included in the Village as effectually as if it had originally been a part thereof.

Section 4. The Village Clerk is hereby directed to file a certified copy of this Ordinance with the Minnesota Municipalities Commission, the Minnesota Railroad and Warehouse Commission, the County Auditor and the Secretary of State.

Section 5. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4.
