AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF WAITE PARK TO INCLUDE CERTAIN PLATTED LAND

The Council of the Village of Waite Park, Minnesota, ordain:

Section 1. A Petition has been filed with the Governing body of the Village of Waite Park, Minnesota, by the sole owner of the following described real estate to have such land included within the Village of Waite Park, Minnesota.

Lots numbered Three and Four (3 & 4), in Block numbered Thirteen (13), in Oakdale, a Subdivision in Section Numbered Sixteen (16), Township Numbered One Hundred Twenty-four (124) North of Range Numbered Twenty-eight (28) West, according to the plat and survey thereof now on file and of record in the office of the Register of Deeds in and for the County of Stearns and the State of Minnesota,

Section 2. The Village Council hereby determines:

Section 5. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4.
