AN ORDINANCE ANNEXING CERTAIN TERRITORY TO AND EXTENDING THE CORPORATE LIMITS OF THE CITY OF FAIRMONT, MINNESOTA

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FAIRMONT, MINURSOTA, AS FOLLOWS:
