

ORDINANCE NO. 508

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO AND EXTENDING THE CORPORATE LIMITS OF THE CITY OF FAIRMONT, MINNESOTA

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FAIRMONT, MINNESOTA, AS FOLLOWS:

Section 1. That a petition presented to the City Council of the City of Fairmont, Minnesota, requesting that property hereinafter described be annexed to the City of Fairmont has been signed by the owner of said property; that the said property abuts upon the corporate limits of the City of Fairmont, Minnesota; that it is so conditioned to be property, subject to municipal government; that the unplatted part thereof does not exceed two hundred (200) acres in area; that the annexation will be to the best interest of the municipality and the territory effected; that said petition is in accordance with M.S.A., Section 414.03 and is in all things sufficient.

Section 2. That the property set forth in said petition is located in the County of Martin, State of Minnesota, and described as follows, to-wit:

Lot Eight (8) and Lot Nine (9) of Block Three (3), Shoreacres, as per plat thereof of record in the office of the Register of Deeds in and for the County of Martin and State of Minnesota, the same being a part of Government Lots One (1), Two (2) and Five (5) of Section Eighteen (18), Township One Hundred Two (102), Range Thirty (30). Also

A tract of land in Lot Seven (7), Block Three (3), Shoreacres, Section Eighteen (18), Township One Hundred Two (102) North, Range Thirty (30), West of the Fifth Principal Meridian, described as follows:

All of Lot Seven (7), Block Three (3), except the following described tract; beginning at a point on the east line of said Block Three (3) 185 feet south of the northeast corner thereof; thence West 139.5 feet to a point marked by an iron stake on the tangent of a curve; thence southwesterly 146.3 feet to an iron stake on the arc of said curve or radius 641.94 feet and central angle $13^{\circ} 3' 20''$; thence East 155.85 feet to said east line of Block 3; thence North 144.0 feet to the point of beginning; area 0.49 acres.

and that said property be, and the same hereby is, extended to and incorporated within the corporate limits of the City of Fairmont, Minnesota, and is hereby declared to be a part of the City of Fairmont, Minnesota, as effectually as if the same had been originally a part thereof and that the corporate limits be and the same hereby are extended to include said property.
