ORDINANCE NO. 988

RESOLVING THE CORPORATE LIMITS OF THE CITY OF  
AUSTIN TO THE NORTH

WHEREAS, Geo. J. Herbol & Company, a  
Soleure Corporation, and Lydia Salmach are the  
sole owners of the land hereinafter-described, and

WHEREAS, said owner above-mentioned, has  
petitioned the Common Council of Austin, Minnesota  
to have the hereinafter-described premises annexed  
to the corporate limits of the city of Austin,  
Minnesota, and

WHEREAS, said premises adjoin the City of  
Austin and are subject to incorporation within the  
corporate limits of Austin, Minnesota by petitioning  
to the governing body of the City of Austin, and

WHEREAS, said premises hereinafter-described,  
are about to become urban in character and muni-  
cipal government of the area hereinafter-described  
is required, in order to protect the public health,  
safety and welfare of said territory and to regulate  
construction therein which may be reasonably expected  
to occur within a reasonable time and annexation of  
the premises hereinafter-described is for the best in-  
terest of the City of Austin and the territory to be  
annexed, and

WHEREAS, said premises are well fitted to be  
under municipal government and are well adapted for  
municipal use and

WHEREAS, the premises hereinafter-described  
desired to be annexed are less than two hundred (200)  
acres and the petition for annexation has been signed  
by all owners of the annexed property.

NOW, THEREFORE, THE COMMON COUNCIL OF THE  
CITY OF AUSTIN, MINNESOTA DO ORDER:

SECTION 1. The land hereinafter-described  
to be added to and incorporated within the corporate  
limits of the City of Austin, Minnesota and said Common  
Council does hereby declare said premises hereinafter  
described to be incorporated within and to be a part  
of the City of Austin, Minnesota. The premises are  
described as follows:

100-20-1-14

The following-described portions of Block Addition in the Town of Lansing, Mason County, Minnesota, according to the plot of said addition recorded in the office of the Register of Deeds of said county: lots 1, 2, 3, 4, 5, 6, 21 and 22 in Block 2; lots 1, 2, 3, 4, 5, 6, and 7 in Block 4; and the West 330 feet of Lot 1 except the South 150 feet of said West 330 feet; including the following-described public street areas in said addition: (a) that part of Elizabeth Street (now called Ninth Street Northeast) lying North of the South line of said Lot 7 in Block 4 and Lot 21 in Block 2 and of said line extended, (b) that part of County Aid Road No. 6-6 (now called Eighth Drive Northeast) lying North of the South line of said Lot 6 in Block 2 and said line extended, and lying Southeast of the centerline of said road, and (c) that part of Margaret Street (now called Eighteenth Avenue Northeast) lying East of said County Aid Road No. 6-6.

SECTION 9. The above-described land extending the corporate limits of the City of Austin, Minnesota, shall be added to the end of Chapter 2300, Austin Compilation in the regular chronological order.
