ORDINANCE NO. 132

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF CAMBRIDGE, ISANTI COUNTY, MINNESOTA, TO INCLUDE CERTAIN PLATTED LAND.

WHEREAS a certain Petition requesting annexation of the territory described below has been duly presented to the Council and said Petition was duly signed by all of the owners of said territory:

THE VILLAGE COUNCIL OF CAMBRIDGE ORDAINS:

Section 1. Declaration. It is hereby determined that the territory described below abutts upon the Village and is so conditioned as properly to be subjected to Village government.

Section 2. Territory Annexed. The corporate limits of the Village of Cambridge are hereby extended to include the territory described as follows:

Those parts of Government Lots Four (4) and Five (5) in Section Twenty-nine (29), Township Thirty-six (36), Range Twenty-three (23), described as follows, to-wit: Commencing at the intersection of the extension Westerly of the center line of Fifth Avenue N. W., a public street in the Village of Cambridge, as now located and established and the West line of Rippey's Addition, a recorded plat in the Village of Cambridge; thence South  $89^{\circ}58'54''$  West along the extension of said center line to the intersection of said center line with the West line of Lot Eighty-two (82), Auditor's Sub-Division No. Eight (8), of the Village of Cambridge, FOR THE POINT OF BEGINNING OF THE TRACT TO BE DESCRIBED: thence continuing South  $89^{\circ}58'54''$  West along the extension of said center line to the Northwest Corner of Lot One (1), Block Two (2), Sunset Knoll; thence South  $9^{\circ}23'33''$  West a distance of 511.62 feet; thence South  $18^{\circ}11'46''$  East a distance of 285.55 feet; thence South  $68^{\circ}28'24''$  East a distance of 150 feet; thence South  $78^{\circ}16'06''$  East a distance of 165.14 feet; thence South  $22^{\circ}50'50''$  West a distance of 157.44 feet; thence due South a distance of 66 feet; thence South  $89^{\circ}56'36''$  East to the West line of said Lot 82, Auditor's Sub-Division No. 8; thence North on the West line of Lot 82, Auditor's Sub-Division No. 8, to the point of beginning and there to terminate.

The aforesaid tract of land also being described as that part of Sunset Knoll lying and being West of the West line of Lot 82, Auditor's Sub-Division No. 8, of the Village of Cambridge.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance in the office of the Secretary of State, in the office of the Municipal Commission

established by Laws 1959, chapter 686, and in the office of the  
County Auditor of Isanti County, Minnesota.

Section 4. Effective Date of Annexation. Annexation  
shall be complete from and after the date when certified copies  
of this Ordinance have been filed as directed in Section 3 hereof.
