AN ORDINANCE DECLARING CERTAIN  
LAND TO BE ANNEXED TO THE CITY  
OF NORTH HANKATO, MINNESOTA.

THE COMMON COUNCIL OF THE CITY OF NORTH HANKATO, MINNESOTA,  
DO ORDAIN AS FOLLOWS:

SECTION 1. All that tract or parcel of land lying adjacent  
to the City of North Hankato and being all in the County of Nicollet,  
and described as follows:

Lot Eight (8) Pleasant View Subdivision, part of the  
E $\frac{1}{2}$  of NE $\frac{1}{4}$  of SE $\frac{1}{4}$ , Sec. 10, T 106 N, R 27 W, and part  
of NW $\frac{1}{4}$  of SW $\frac{1}{4}$ , Sec. 11, T 106 N, R 27 W.

is hereby deemed to be suitably conditioned for municipal government  
and is hereby annexed and hereby declared to be a part of the City  
of North Hankato, County of Nicollet, State of Minnesota, and to be  
included in the corporate limits thereof.

SECTION 2. This ordinance shall take effect from and after  
its passage and publication.
