ORDINANCE # 49

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF RAYMOND, AND DECLARING SAME TO BE AN ADDITION TO SAID VILLAGE.

WHEREAS, ALBERT G. ONNEN AND AGNES ONNEN, HUSBAND AND WIFE, AND IRVIN HOLTZ AND IRENE HOLTZ, HUSBAND AND WIFE, HAVE HERETOFORE PRESENTED TO THE VILLAGE COUNCIL OF THE VILLAGE OF RAYMOND, A PETITION DULY VERIFIED, THAT THEY ARE THE SOLE OWNERS OF THE REAL ESTATE HEREINAFTER DESCRIBED, AND THAT SAID REAL ESTATE ABUTS AGAINST AND IS ADJOINING TO THE PRESENT EXISTING BOUNDARY LINE OF THE CORPORATE LIMITS OF THE VILLAGE OF RAYMOND, AND PRAYING THAT THE SAID REAL ESTATE BE ANNEXED TO THE VILLAGE OF RAYMOND ACCORDING TO LAW, NOW, THEREFORE BE IT ORDAINED BY THE VILLAGE OF RAYMOND, AS FOLLOWS:

SECTION 1

THAT ALL THAT CERTAIN REAL ESTATE SITUATED IN THE COUNTY OF KANDIYOHKI AND STATE OF MINNESOTA AND DESCRIBED AS FOLLOWS, TO WIT:

LOT FIVE (5) OF HOLTZ'S ADDITION AS OWNED BY ALBERT G. ONNEN AND AGNES ONNEN HIS WIFE,

AND LOT SIX (6) AND LOT SEVEN (7) AS OWNED BY IRVIN HOLTZ AND IRENE HOLTZ, HIS WIFE.

BE AND THE SAME IS HEREBY ANNEXED TO THE VILLAGE OF RAYMOND AND SAID TRACTS OR TERRITORIES ARE HEREBY DECLARED TO BE A PART OF AND ARE ADDITIONAL TO THE VILLAGE OF RAYMOND, MINNESOTA.

SECTION 2.

THAT THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS PUBLICATION.

DOES ORDAIN AS FOLLOWS:

THAT ALL THAT REAL ESTATE SITUATED IN THE COUNTY OF KANDIYOHI AND STATE
OF MINNESOTA AND DESCRIBED AS FOLLOWS: TO WIT:

"LOTS FIVE (5), SIX (6), AND SEVEN (7), HOLTZ'S ADDITION IN THE
SOUTHEAST QUARTER (SE $\frac{1}{4}$) OF SECTION NINETEEN (19), TOWNSHIP ONE
HUNDRED EIGHTEEN (118) NORTH, RANGE THIRTY SIX (36) WEST, KANDIYOHI
COUNTY, MINNESOTA, ACCORDING TO THE RECORDED PLAT THEREOF"

BE AND THE SAME IS HEREBY RELEASED FROM EDWARDS TOWNSHIP, SO THAT IT CAN
BE ANNEXED TO THE VILLAGE OF RAYMOND.
