ORDINANCE # 49

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF RAYMOND, AND DECLARING SAME TO BE AN ADDITION TO SAID VILLAGE.

WHIREAS, ALBERT G.
