

ORDINANCE NO. 95

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LAKE CRYSTAL, MINNESOTA, TO INCLUDE CERTAIN PLATTED LAND.

Section 1. A petition has been filed with the governing body of the City of Lake Crystal, Minnesota, by the sole owner of the following described real estate, to have such land included within the City of Lake Crystal, Blue Earth County, Minnesota:

Beginning at a point three hundred (300) feet South of the Northwest (NW) corner of Lot Three (3) of Oakley's Outlots to the City of Lake Crystal, Minnesota; thence running East Sixty-six (66) feet to the westerly boundary line of Lot Four (4) of Oakley's Outlots; thence North (N) One hundred fifty (150) feet along the said westerly line of said Lot Four (4); thence East Sixty-six (66) feet to the westerly line of Lot Five (5) of Oakley's Outlots; thence South (S) along said westerly line One hundred eighty (180) feet; thence East Sixty-six (66) feet to the Easterly line of said Lot Five (5); thence South along said Easterly line One hundred eighty (180) feet; thence West One hundred sixty-five (165) feet; thence North One hundred fourteen (114) feet; thence West Thirty-three (33) feet to the westerly boundary line of Lot Three (3) of Oakley's Outlots; thence North (N) to the point of beginning; all being in the Northwest Quarter of the Northwest Quarter (NW1/4) of Section Four (4), Township One hundred seven (107) North, Range Twenty-eight (28) West.

Section 2. The quantity of land embraced within the foregoing petition and bounded as described is less than one and one-eighth acres.

Section 3. The City Council hereby determines that the annexation will be to the best interests of the City of Lake Crystal, Minnesota, and to the territory that is affected; that the territory described herein abuts upon the city and is so conditioned as is properly to be subjected to city government.

Section 4. Therefore, the City of Lake Crystal, Minnesota, hereby ordains and declares that the property herein described be and is hereby annexed to and included in the City of Lake Crystal, Minnesota, as effectually as if it had originally been a part thereof.

Section 5: This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof in the Minnesota Municipal Commission, the County Auditor, and the Secretary of State, and from and after ten days its passage and publication.
