




An Ordinance Annexing Part of Section 20,
Township 30 North, Range 21 West, in Washington
County, to the Village of Mahtomedi.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO ORDEIN AS
FOLLOWS:

Section 1. That pursuant to that certain petition signed
by all of the owners of the land hereinafter described, in
Washington County, Minnesota, containing less than two hundred
acres, abutting on the Easterly side of the Village of Mahtomedi,
requesting the annexation of said land to said Village, said
Petition having been duly filed with the Clerk of said Village;
and it appearing that such annexation will be to the best interests
of the Village and of the territory affected, the Village boundaries
of the Village of Mahtomedi are hereby extended to include said land
described by the following boundary lines:

All that part of the East $\frac{1}{4}$ of the Southeast $\frac{1}{4}$
of Section 20, Township 30 North, Range 21 West,
described as follows:

Beginning at the Southeast corner of Lot 6 of the
East Shore Garden Lots, thence East on the South
line of said Lot 6 produced to the East line of
said tract, thence North along the said East line
of said tract to a point which is due East of the
Northeast corner of Lot 6 of the East Shore Garden
Lots, thence West on a line to the Northeast corner
of Lot 6, thence South along the East line of Lots
6, 7 and 8 of the East Shore Garden Lots to the
Southeast corner of said Lot 8 to the point of
beginning, together with Lot 8 of East Shore Garden
Lots, except a strip of land 25 feet wide lying
Easterly of and adjacent to the East line of Lot 6
of East Shore Garden Lots.

and that said territory is hereby made a part of the Village of
Mahtomedi as effectually as if the same had originally been a part
of said Village.

Section 2. This Ordinance shall take effect and be in force
upon the filing of a certified copy thereof with the County Auditor
of Washington County and the Secretary of State of the State of
Minnesota and with the Minnesota Municipal Commission and from and
after its publication.
