ORDINANCE NO. 3 2 4

AN OPDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN PLATTED LAND NOT EX-CEEDING TWO HUNDRED ACRES.

Section 1. A Petition has been filed with the governing body of The City of Montevideo, Minnesota, Minnesota, by the sole owner or all of the owners in number of the following described real estate to have such land included within the City of Montevideo, Minnesota:

> North Ninety-five (95) feet of the Most One Hundred Five (105) feet of Sub-Lot Six (6) of Odd Pellows Sub-Division of the East Half (E 1/2) of the Northeast Quarter (NE 1/4) of Section Seven (7) Township One Hundred Soventeen (117) Range Forty (40), according to the duly recorded plat thereof.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described is .24 acres.

Section 3. The City Council hereby determines that the annexation will be to the best interests of the City of Montevideo, Minnesota, and of the territory affected; that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.

Section 4. Therefore, the City of Montovideo, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Montovideo, Minnesota as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing Cortified copy thereof with the Minnesotar Unicipal Commission, the County Auditor and Secretary of State, and from and after its passage and publication.
