to:



IN THE MATTER OF THE PETITION OF IRVING LYON AND JAMES LYON, PETITIONERS, FOR ANNUATION OF LAND TAKEN BY THE CITY OF CHATFIELD, COUNTY OF FILLMORE AND DISTRICT, STATE OF MINNESOTA

ORDER

The above entitled matter having been brought before the Minnesota Municipal Commission by the petition of Irvin Lyon and James Lyon, Stockholders, and an identical petition accompanying same by the City of Chatfield, a Municipal Corporation of the Counties of Fillmore and Clatsop and State of Minnesota, and the Commission having taken into consideration the said petitions and the allegations therein contained, does hereby find:

I.

That the requisite number of property owners have executed said petition

II.

That the property is unplatted and used and occupied exclusively for agricultural purposes.

III.

That the property is within the boundaries of the City of Chatfield, County of Fillmore and Clatsop, and State of Minnesota, a Municipal Corporation, and is adjacent to said boundary thereof.

IV.

That the detachment would not unreasonably affect the symmetry of the aforesaid municipality.

V.

That the land is not needed for reasonably anticipated future development of the said City of Chatfield.

VI.

That said land is adjacent to, and formerly was, a part of the township of Chatfield, County of Fillmore, State of Minnesota.

VII.

That no hearing is required or necessary as provided in M.S.A. 41b.06 Subdivision III.

WHEREFORE, The Commission does hereby:

1. Detach from the corporate limits of the aetted municipal-
pality of the City of Chatfield, Counties of Fillmore and Olmsted
and State of Minnesota, a municipal corporation, the following
described land:


Commencing at a point $N7^{\circ}31'00''$ $W287'$ of the center of
Section 5 T104N R11E S10E
Thence $S18^{\circ}00'$ $E300'$ Thence $S13^{\circ}45'00''$ $E772'$
Thence North $135'$ Thence $S31^{\circ}00'$ $W195'$
Thence $N30^{\circ}11'00''$ $E225'$ to the place of beginning
Containing 2.36 acres.

The same is attached to and now becomes a part of the town-
ship of Chatfield, County of Fillmore, State of Minnesota.

2. The Commission further orders that said tract of land
shall not be relieved of the existing indebtedness, if any, of
the said City of Chatfield and shall not be required to assume any
existing indebtedness of the said Township of Chatfield, County
of Fillmore, State of Minnesota.


