AN ORDINANCE ENTENDING THE CORPORATE LIMITS OF THE CITY OF MARSHALL TO INCLUDE CERTAIN UNINCORPORATED PROPERTY CHIED BY AND ABUTTING UPON THE LIMITS OF THE CITY.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village, or borough; and

WHERMS, sold territory abute upon the corporate limits of the City of Marshall at the mortherly & northwesterly boundary thereof and is deemed to be arban in character; and

WHEREAS, said territory is owned in fee by said City;

The Common Cowncil of the City of Marshall do ordain as follows;

Section 1, Territory Annamed. The corporate limits of the City of Marshall are hereby extended to include the unplatted property located in the County of Lyon, State of Minnesota, and described as follows now owned by said City:
