An ordinance to amend certain sections of the Village Code of the Village of New Richmond, Minnesota

SECTION 1. PART OF THE VILLAGE OF NEW RICHMOND, MINNESOTA, IS TO BE

**SECTION 2.** That the owners of the tract, parcel and piece of land described hereinafter to the corporate limits of the Village of New Richmond, Minnesota hereinafter described, were petitioned the council of the Village of New Richmond to have the following described property in the County of Lacrosse and the State of Minnesota, annexed to the Village of New Richmond, to-wit:

A tract of land lying within the Northeast Quarter of the Northwest Quarter (NE 1/4 of NE 1/4) of Section Twenty (20), Township One Hundred Five (105) North of Range Twenty-two (22) West, circumscribed as follows, to-wit: commencing at the Northwest corner of lot 1, Block 2, Witoshko's Subdivision in the Village of New Richmond, Lacrosse County, Minnesota, thence running South along the West line of said Block 2 of said Witoshko's Subdivision a distance of 312 feet to the Northwest corner of lot 60, of Auditor's Plat No. 4, New Richmond, Lacrosse County, Minnesota, thence West 166 feet, thence North and parallel with the West line of said Witoshko's Subdivision, a distance of 415 feet to the North line of said Northeast Quarter of Northwest Quarter (NE 1/4 of NE 1/4) of Section 20, Township 105 North of Range 22 West, thence East along the said North line of said Section 20, a distance of 166 feet, thence South 32 feet to the place of beginning.

Also described as: All of lots 1 and 2 in Smith's Addition to the Village of New Richmond, County of Lacrosse, State of Minnesota, together with the adjoining streets and alley according to said plat; West Weaver Street from the proposed corporate limits to the East line of St. Thomas Street. St. Thomas Street from the North line of Section Twenty (20), Township One Hundred Five (105) North of Range Twenty-two (22) West to the South proposed corporate limits and that alley located between said lots 1 and 2, Smith's Addition.

**SECTION 3.** The petitioners are the owners of said property and the owners adjacent to the streets therein named, and whereas the annexation will be to the best interests of the Village of New Richmond and the territory affected.

**NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE VILLAGE OF NEW RICHMOND, MINNESOTA,** pursuant to the authority and provisions of Minnesota Statutes Annotated, Section 444.03, Subdivision 2:

**Section 2.** That the property heretofore described be and the same hereby is annexed to the Village of New Richmond, Minnesota.

**Section 3.** BE IT FURTHER ORDAINED AND ENJOINED, That a duly certified copy of this Ordinance shall be filed and recorded in the office of the Register of Deeds of Lacrosse County, Minnesota.

Section 4. This Ordinance shall take effect and be in force from and after its publication.


