ORDINANCE NO. 179

AN ORDINANCE TO EXTEND THE BOUNDARIES OF THE VILLAGE OF SAUK RAPIDS AND INCORPORATE ADDITIONAL TERRITORY THEREIN

THE VILLAGE COUNCIL OF THE VILLAGE OF SAUK RAPIDS DOES ORDAIN:

Section 15:25. Village Boundaries Extended. Pursuant to a petition duly signed by the owners of the land in Benton County described as follows:

A tract of land lying in and being part of Northwest 1/4 of Northwest 1/4 of Section 23, Town 36 North, Range 31 West and also in Southwest 1/4 of Southwest 1/4 of Section 14, Town 36 North, Range 31 West described as follows:


Beginning at a point on South line of Section 14, Town 36 North, Range 31 West which is 183 feet East of Southwest corner thereof; thence N 00°10' W parallel to West line of said Section 14 a distance of 66 feet; thence S 88°54' E parallel to South line of said section 14 a distance of 236 feet; thence S 00°10' E parallel to West line of said Section 14 a distance of 66 feet to North line of Section 23, Town 36 North, Range 31 West, said line being also South line of said Section 14; thence South parallel to West line of said Section 23 a distance of 733 feet to centerline of Tenth Street North; thence N 88°54' W on said centerline 216 feet; thence North parallel to West line of said Section 23 a distance of 633 feet; thence N 88°54' W a distance of 20 feet; thence North parallel to West line of Section 23 a distance of 100 feet to point of beginning, said tract containing 4.04 acres, more or less, and subject to any and all easements of record and platted as "LARSON'S 5TH ADDITION".

The territorial limits of the Village are hereby extended to include such land within its limits, which shall be hereafter governed as other territory of the Village is governed.

Section 15:26. Copies to be filed. The Village Clerk shall forward a certificate of this ordinance to the Secretary of State, the Minnesota Municipal Commission and to the County Auditor for Benton County, Minnesota.

Section 15:27. Effect. Such land shall be annexed upon the filing of the Certified copies hereof with the Secretary of State, The Minnesota Municipal Commission and the County Auditor.

Passed by the Village Council this 21st day of May, 1963.


