AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MONTEVIDEO, MINNESOTA TO INCLUDE CERTAIN PLATTED LANDS.

THE CITY OF MONTEVIDEO DOES ORDAIN AS FOLLOWS:

SECTION I. A Petition having been filed with the governing body of the City of Montevideo, Minnesota, by the sole owner of the following described real estate to have such land included within the City of Montevideo, Minnesota:

Lot Six (6) of Block Four (4) in Ira B. Wolfe's Second Subdivision in the Southeast Quarter of the Southeast Quarter (SE 1/4 SE 1/4) of Section Six (6) Township One Hundred Seventeen (117) Range Forty (40), County of Chippewa State of Minnesota, according to the duly recorded plat thereof,

SECTION II. The quantity of land embraced within the foregoing description, is .44 acres.

SECTION III. The City Council hereby determines that the annexation will be to the best interest of the City of Montevideo, Minnesota and of the territory affected; that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

SECTION IV. Therefore, the City of Montevideo, Minnesota does hereby ordain and declare that the property hereinbefore described be, and the same is hereby annexed to and included in the City of Montevideo, Minnesota as effectually as if it had been originally a part thereof, as of the residential use district.

SECTION V. This Ordinance shall be final and shall take effect upon and after its passage and publication as by the City Charter provided and upon the filing of a certified copy thereof with the Minnesota Municipal Commission, the County Auditor and Secretary of State of the State of Minnesota.
