WHEREAS, the Council believes
that this change in election date
should be made in this village;

THE VILLAGE COUNCIL OF
HILLS, MINNESOTA, ORDAINS:

Section 1. Commencing with
the 1963 Village election, the
regular Village election of offi-
cers shall be held on the first
Tuesday after the first Monday in
November of each year.

Section 2. This ordinance shall

publication.
