AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF INTERNATIONAL FALLS TO INCLUDE CERTAIN UNINCORPORATED LANDS THE BOUNDARIES OF WHICH ARE ADJACENT TO THE CITY LIMITS.

WHEREAS, a certain petition dated July 23, 1953, requesting annexation of the territory hereinafter described was duly presented to the council on the 23rd day of August, 1953; and

WHEREAS, the quantity of land embraced within the area described in the petition and bound as described is less than 200 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or township; and

WHEREAS, the petition was signed by all the owners of said land; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits on the westerly boundary thereof;

The council of the city of International Falls, Minnesota ordains:

Section 1. The city council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or township.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

That part of the Southwest Quarter of the Southwest Quarter (SW 1/4 SW 1/4) Section Thirty-three (33), Township Seventy two (72), Range Twenty-four (24), situated in the County of Koochiching and contained within the following area and bounds:

Beginning at the southeast corner of the plat of Twenty Addition Block One (1) and Two (2) shown north along the extension of the west line of 15th Avenue in the said plat, a distance of 502.07 feet, thence angling east 24° - 25' - 00", a distance of 153.00 feet to a point on the north line of said SW 1/4 SW 1/4, thence east 650.00 feet along the east side of said SW 1/4 SW 1/4 to the north line of 15th Avenue in said plat, thence west along the north line of said 15th Avenue 602.07 feet to the point of beginning.

Section 3. Action. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect thirty (30) days after its passage and approval and the filing of the certified copies as directed in Section 3.
